





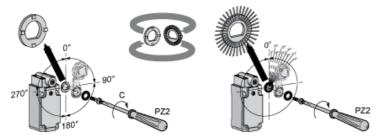
#### Head Rotation Adjustment

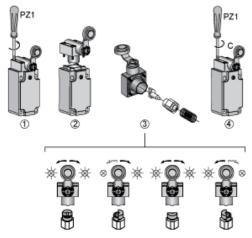
## Lever Angle Adjustment


