<b>Description of change</b>	<p>The Connect ME/EM is a secure device server module that provides network connectivity. As of January 1, 2020, the California Consumer Privacy Act SB-327 requires all cellular and internet connected devices manufactured after that date to have unique default passwords for each device. This requirement increases security and reduces the likelihood of intrusion and malicious attack. Many Digi products already comply and have unique passwords per device. However, Digi is updating all remaining products to come into compliance.</p> <p>The Connect ME/EM Plug and Play 2MB models can't be updated due to memory space so they will be End-of-Life. The 4MB Connect ME models will be updated and are a direct replacement for the 2MB Connect ME.</p>

In order to meet the SB-327 requirements, the changes in the operating system requires a minimum of 4MB of Flash. The 2 MB devices cannot be altered, which forces an End-of-Life.
